This workshop enables delegates to develop their knowledge and skills regarding the structure of an Initial Child Protection Conference and the requirements of professionals involved. Delegates

will be able to access pre-course material, which provides information regarding a devised case. During the workshop, delegates will be asked to draw upon this information and play an active role in a mock Child Protection Conference for this case. The mock Child Protection Conference will be chaired by a Hampshire Independent Reviewing Officer, allowing delegates the opportunity to experience the way that a Child Protection Conference is run.
